



# Declarations under the National Emergencies Act, Part 1: Declarations Currently in Effect

Updated February 28, 2019

On February 15, 2019, President Trump [declared](#) a national emergency under the [National Emergencies Act](#) to aid in the construction of physical barriers along the U.S. border with Mexico. Besides raising questions about whether a national emergency declaration can facilitate the construction of such barriers (a topic discussed in a [related Sidebar](#)), the declaration has also prompted more general interest in the National Emergencies Act, including in other emergencies declared under the Act that are currently in effect.

This Sidebar—the first of a two-part series identifying declarations issued under the National Emergencies Act, provides a Table identifying national emergency declarations that are **currently in effect as of February 15, 2019** (the companion Sidebar, identifying declarations no longer in effect, can be found [here](#)). The Table notes when later Executive Orders or Presidential Proclamations modified the initial executive action in which a national emergency was declared. The Table also lists statutory authorities cited to support the initial Executive Order or Presidential Proclamation, along with statutory authorities expressly cited in those documents as the legal basis for actions taken in response to the declared emergency. Finally, the Table identifies the date when the declared emergency was last extended or, if it has not been extended, the date when it is currently set to expire.

This list was generated by searching the Presidential Documents database on Westlaw for citations to the National Emergencies Act and the terms *emergency* and *declare* or *proclaim*, and by reviewing presidential actions posted on the White House website on February 15, 2019 following announcement of the declaration that day. To determine the status of each declared national emergency, we consulted the [Executive Orders Disposition Tables](#), produced by the National Archives, and searched the *Federal Register* database on Westlaw for the Executive Order or Presidential Proclamation number and variations and combinations of the terms *contin!* or *revok!* or *rescind!* or *termin!*.

In part because there is little case law on the matter and the Executive [has arguably taken conflicting views](#) over the years on the Act's relationship with other statutes, this Sidebar identifies only those Executive Orders and Presidential Proclamations that **expressly invoke** the National Emergencies Act.

<sup>1</sup> This column only lists statutes expressly identified in the initial Executive Order or Presidential Proclamation as providing the basis for a specific substantive provision within the executive action. For example, the column does not identify United Nations Security Council Resolutions cited in support of certain actions. Additionally, other sources of authority that might be relied upon as the basis for a particular provision within the Order or Proclamation are not identified. For instance, [Executive Order No. 13,694](#) provides that covered persons shall be denied entry into the United States; though not expressly providing that such denial is pursuant to Section 212(f) of the Immigration and Nationality Act, the order cross-references a Presidential Proclamation that relies upon to Section 212(f) as its legal basis. Neither the earlier Presidential Proclamation nor the statutory provision cited therein is listed in the Table.
